2012 Festival in the Park Entertainment Application

Festival in the Park will be held rain or shine **Saturday June 16, 2012, 11am until 6pm**

Entertainment Regulations:

1. By signing this agreement you signify that you agree to comply with all terms of this agreement.
2. Gay Grassroots is a non-profit organization and PensacolaPRIDE is a not-for-profit event. When possible, entertainers are requested to donate all or part of their fee, travel and lodging. If payment for performance is agreed to prior to the event, performers will be paid at the conclusion of the performance. Priority consideration will be given to acts who donate their time and/or secure their own sponsorship.
3. Each act will be allowed to use a table (provided by the PensacolaPRIDE committee) to sell CDs shirts, performance tickets, etc., during their time on stage, and for 30 minutes after the conclusion of their performance. If an entertainer decides to offer something for sell, these items must be approved by the PensacolaPRIDE committee in advance. Material deemed offensive by Pensacola Pride will not be permitted to be sold or displayed. Any vendor refusing to remove such material may be requested to leave with no refund. The table must be manned by a representative of the entertainer.
4. The event will be held rain or shine.
5. All scheduled entertainment slots will be assigned. Acts are required to sign in 30 minutes before their scheduled performance time. Failure to adhere to assignments could result in forfeiture of participation in future events and entertainer may be requested to leave WITHOUT RECEIVING PAYMENT.
6. Extremely loud music, amplified voices, squawk boxes, or any other type of sound amplification that would interfere with the surrounding tenants is NOT PERMITTED.
